8. All cooking must take place at the competition
9. The team must provide utensils
10. One of the team members must be at the stand at all times
11. Participants must observe proper safety and hygiene practices
12. Meal Vouchers will be sold at R20 (per plate) and Participants may redeem vouchers at the end of the event.
13. Teams must start between 08:00 and 10:00 (not later than that)
14. Potjies will be judged on aroma, taste and presentation
15. Prize will be awarded for the stand decorations and best dressed team with the most SPIRIT
16. Judging will take place from 14:00
17. Prizes will be presented at 16:00
